

2022 AMND TERMS OF REFERENCE AMENDMENTS

The Adelaide Metropolitan Netball Division (AMND) has considered the possible scenarios that could come into play during the 2022 AMND Competition in relation to COVID-19 restrictions and the disruption this could cause to the Competition. AMND therefore advises the following rule additions / amendments:

COVID-19 Extenuating Circumstances Rule

If COVID-19 restrictions have an impact on the AMND Competition, the AMND Committee has the ability to override the current AMND Terms of Reference for the 2022 season.

Substitution	The GO Division is amended to read Sub Primaries/	Change of name only
Provisional Player	A Provisional Player no longer applies in the Competition.	Provisional Player arrangements changed from Season 2020 with the introduction of single game vouchers.
9.1.1	In all Grades, there shall be, wherever possible, at least one (1) round of minor round Matches.	This clause continues in case of potential major disruption during the Season.
10.1.3	All Players must be registered on PlayHQ in order to have Matches qualify towards the Finals Series. Single game vouchers do not qualify as a Match in the Competition.	MyNetball has been replaced by PlayHQ. Important clause re Match qualifications for Finals Series.
10.1.4	All Player registration fees must be paid in full at the time of registration on the PlayHQ website.	
10.2.7	Clubs with two (2) Teams in the same Grade can interchange a maximum of two (2) Players in a Match during the Minor Round between the two (2) Teams.	Minimises potential Covid impacts to a Club and disruptions with Player movements especially if the next lowest Team is not in an immediate lower Grade.
10.2.9 a)	Refer Next Two Pages. Please read this clause carefully	New clause for Players playing 2 Matches in a day.
10.2.19	A Player is ineligible to play in the AMND Senior Competition and the State Premier Netball Competition in the same week / day in which Matches are held. For this clause, a week is defined as a Sunday to the following Saturday inclusive. However, when more than one (1) Premier League Competition match is played between Monday to Saturday in the same week, a week is defined as a Monday to the following Thursday inclusive.	Allows for more than one Premier League match in a week

Definition / Clause No.	Rule
10.2.9a)	<p>If it is deemed necessary, a Player may play two (2) Matches in the Competition on the same day, although it is preferred for Clubs to utilise the single game voucher arrangement wherever possible. On the basis a Player is required to play two (2) Matches on the same day, the following conditions will apply</p> <ul style="list-style-type: none"> i). The Player may only be the 6th or 7th Player in the Team they are ‘topping up’ on that day of the Match (ie the Team requiring ‘topping up’ will have a maximum of seven (7) Players for that Match). ii). The relevant Team that requires ‘topping up’ may only have a maximum of two (2) Players playing for their Team who will play two (2) Matches on that day. iii). For the Senior Competition, the Player(s) who play for the Team that requires ‘topping up’ may only move up or down from the Clubs’ immediately higher or lower Grade Team. iv). For the Age Competition, the Player may only play in a Division in a latter time slot in a higher or equivalent Grade. v). The two (2) Teams from the Club whose Player(s) will be undertaking movement, must submit their scorecards to the Duty Room on the day prior to commencement of both of the Matches. The scorecards must have the unavailable Players' names crossed out and the Players' names (who are intended to play the 2 Matches on the same day) written on the scorecard, noting the other Grade they expect or have already played in the other Match on that day. The scorecards will then be checked and signed off by a Member of the Management Committee. vi). This clause 10.2.9a) does not apply to all Grades. A Player who has taken to the court in any Match in the 2022 State Premier Netball Competition as per clause 10.2.19 or the following Grades in the 2022 Competition, being AMND League, A Grade, B1 or any Intermediate Grade, is not permitted to play two (2) Matches on the same day. vii). For the purposes of qualifying for Finals for the Seniors Competition, only the highest Grade played by a Player who plays two (2) Matches on the same day, will be counted towards Finals eligibility. viii). For the purposes of qualifying for Finals for the Age Competition, only the younger Grade played by that Player on the day of the Match will be counted towards Finals eligibility.

Note: The 2022 draw / fixture is a flexible document and can changed at any time during the Season and impacted Clubs will be advised accordingly
